Any meaningful development Model must address the physical, psychological and spiritual needs of individual citizens. Africa's soil breeds her own needs, education, environment, experience, potentials and so our loci of development should be different and must be original to Africa from foundation to apex. (Igbo call it "odi na na na e bu eke") Every soil grown its own kind of snake (plant).

We have chosen to call it the Lily's Model because like the proverbial Lily, it is envisaged to be pure, original, independent, faultless, uninfluenced by its environment, innocent of other development models. We can argue that all developments that are sustainable must adopt or had adopted Lily's Model of its own crafting without knowing it. Our attempt/effort is to delineate what Lily's Model entails? How does it work and how do we apply it to achieve development? Why Lily's Model is unique is that, it is inward looking, introspective, exploitative, not-dependency forming, deserving and convenient. It decries 'copy catism' and obnoxious integrativism. - ix. To effect regime change immediately a transformational leader emerges in any African country.
- x.To manipulate Africa's economy, leadership and development by using CIA, KGB and multinational corporations.
- xi. To encourage brain-drain
- xii.To ensure that Africans do not pursue Lily's Model of Administration.
- xiii.To undermine the economic growth of his nation.

To grow and develop, we must develop an independent mind and indigenous mind like Mu'ammar Gaddafi of Libya.

The problem faced by African leaders/politicians is that they have been contaminated. We begin by seeking to satisfy immediate and people's needs like food, housing, clothing, education, thereafter there can be intra African exchange on the basis of comparative advantage.

When we consolidate, then we can begin to extend our products to the outside world. Globalisation, United Nations is all western subterfuges for entrenching and perpetuating European dominance and neo-imperialism. They must be kept at arm's length.

# Application of Lily's Model of Development

Applying Lily's model of development implies the following:

- That there can't be development without ethically sound leadership foundation
- Development is hinged on detest of corruption in all its ramifications.
- The need to know and work out implementable trajectory for development.
- The availability of political will to pursue and achieve the blueprint clearly articulated.
- The need to dispassionately choose competent hands to drive the programme of development.

- The need to harness the human and non-human potentials that are innocuous for the achievement of desired, developmental objectives.
- It has to involve the knowledge that every national development must be humanistic or human —centred. Any development that does not impact positively on the living conditions of the citizens is mal-developmental. (Ikeji and Ekot 2002)

Development is about the multifaceted improvement of the living standards of the people through multisectoral approaches. There is the need for the improvement of the materials, spiritual, psychological, social, economic and political well-being of the citizens.

This will include provision of basic needs like food, water, housing, clothing, power, good roads, health services, education and job opportunities. There has to be an enabling environment for people to pursue their different occupational goals without let or hindrance. (Nyong, 2005).

In Nigeria for instance, we lack an organized, systematic and sustained developmental trajectory. Different leadership dispensations came up with different development programmes which do not meaningfully and logically connect with the vision of past leaders which instead of leading to sustained development leads to development gaps and disarticulation.

Lily's model of development encapsulates a vision where leaders are patriotic, ethically sound, and selfless and are rationally defined by a consciousness of holistic, integrated and harmonious development. But the development trajectory we have is unorganised and disarticulated. This type of development is reduced to the barest minimum, if nepotic considerations are extinguished, developmental policies are goal oreiented, if development is based on sincere national needs and rational utility considerations. For instance, it does not make sense to site a Navy formation in Kano that does not have water, construct rail line from Lagos to Maradi in Niger when rail net work has not been achieved in the six Geo-political zones of Nigeria. We are talking of mining oil in the North when the existing refineries are not functioning.

Nigeria's development agenda is marred by political and nepotistic considerations with scant regard to the real needs of the nation. We must ask the question, what type of development do we have in mind? Technological, agricultural, petro-chemical, automobile or tourism driven development? Or do we intend to develop in all the aforementioned areas. We need to articulate a development plan that will serve as blueprint to which successive leaders will be made to pursue to achieve the desired outcome. (Ekanem, 2010).

All developments achieved so far will need to be articulated and then, the gaps filled to enable us reap the full potential of our developmental efforts. Infrastructural gaps like lack of good roads, power, housing, portable water, transportation, health facilities and affordable education will need to be a filled as a matter of urgency.

A national plan that will make land available for farmers will need to be vigorously pursued. Farmers will need to be supported to make farming lucrative. This is the only way our teeming youths can be encouraged to take to agriculture. Politics should be made less lucrative or attractive else nobody will want to leave the quickest means of enrichment to opt for farming. This means that,

- Corruption must be fought.
- Leadership must be sincere
- There must be laid out plan with prioritizations.
- A nation's vision and the political will to pursue and accomplish the vision.
- Checks and balance must be put in place as enablers, drivers, consciences and gadflies to keep leaders on their toes.

The schools, churches must be used to deal with the character-cancer that destroys our potentials for greatness.

Lily's Model may be accused of being utopian, outlandish, idealistic and impracticable. This will be a defeatist attitude. The Lily's Model is based on the aphorism, that says "shoot at the moon perchance you land on the stars" – if we painstakingly pursue this trajectory, we will arrive at a somewhat progressive outcome.

According to Rooney (1988), Nkrumah, had such clear vision at the onset, but the manipulation of colonial forces discoloured and frustrated the vision. His personal character deficits defeated his good vision. Ghedaffi (2005) had similar vision but like Nkrumah was destroyed by bloated vision to rule and dominate Africa. Lily's Model emphasises humility, love for humanity, justice and patriotism as indispensable first lessons and qualities for aspiring leaders'. Appropriate taxation to dissuade political business men from venturing into politics – clear, clean, transparent voting system leading to peaceful succession should be put in place. Where there is a will, there will be a way. There may be need for the cleaning of the political augean stable for the Lily's Model to be put in place.

### Conclusion

What we have attempted are the main outlines of the Lily's Model of Development. It is coming as a patriotic response to the need to addness the yawning gap that exists in our development parameters. We are working hard but no real development is being witnessed. We have applied the classical model, the Neo-classical, the Agrarian, the capitalist, the socialist, the welfarist, all these models have not helped us. We have passed through Neo communalism, modernization theory, (Industrialization, import substitution, structural Adjustment programme, Multinational corporations, mixed economy, trade liberalization, World Bank, IMF Conditionalities, Globalisation, NEPAD, and other adhoc development programmes and all these theories have not led to the desired destination which is the holistic development of the human person and Africa. A neo-communalist Lilian Model is what this paper is advocating to wean Africans of the corruptions that goes with presidential democratic system of government.

Lily's model of development is concerned with achieving transparent, corruption free and goal oriented development. It insists on true, morally sound and sincere and patriotic leadership. Need for a development blue print and trajectory that is based on locational utility that is, investing in each region of the nation in such a manner as to derive maximum returns on investment. Prioritizing development thinks of basic needs and essential infrastructural needs. Then, the development should be sustained and progressive. We are also to develop bearing in mind areas where we have the highest level of comparative advantage against other competing nations. Also, our development imperatives must be forward looking and in tandem with global realities.

#### Recommendations

We recommend that for Lily's model of development to be adopted in our developmental programme, the following are needed.

- A system that must practice separation of powers in a rational and progressive manner.
- We recommend that Lily's model be applied as a home-grown economic developmental panacea to curb the pitfalls common to developing nations.
- A national independent body should be set up to screen would be leaders to ensure that they are of sound moral character.
- An economic and development think-tank has to be constituted to evaluate the development policies of successive administrations to ensure coordination and continuity.
- Lily's model recommends that both the process and the product of any development trajectory must be seen to follow due process and adhere to the guidelines of transparency and fruitfulness in terms of the impact of development policies on the existential situation of the citizens. The essence of development must be about the wellbeing of the citizens of the nation (Ozumba, 2018).
